Your Code of Conduct is more than a set of rules - it's a statement and a concrete commitment to a set of business conduct standards that supports your mission, values, and culture. This program helps employees understand what your Mission, Values and Code of Conduct are - and the important role they play in defining who you are as an organization.

But this program goes further. Even the best Code won't create a healthy workplace culture on its own. It must inspire and be supported by "culture" skills. So we introduce learners to four foundational skills they need to build a thriving work culture:

- How to build trust at work
- How to make clear decisions
- What accountability means
- The importance of positive cultural norms

This program provokes learners to think about your Mission, Values and Code and the role they play in their work lives. And it empowers learners by showing them how they can help build – or break – the work culture everyone wants.

It also includes short, 2-minute summaries of key Code topics. Include the topics that make sense given your audience and industry. Exclude the ones that don't.

Finally, this program uses Emtrain's unique polling questions to give employers real insight into how learners feel about all the concepts and culture skills presented.
